Functionalities available/actions to be performed by Accounts Administrator (without Bank intervention):

- Creation of new users (with view only/view and transaction facility) for operating the accounts
- ✓ Deletion/modification of existing users
- ✓ Creation of passwords of users
- ✓ Assigning powers to users for different types of transactions
- ✓ Setting-up daily overall limit and transaction type limits
- ✓ Setting up rules (maker/checker or single user) for various transactions
- ✓ Approve increase/modification in daily overall/transaction limits
- ✓ Setting up per day limit for number of Beneficiaries to be created for inter-bank and intra-bank funds transfer
- ✓ To approve addition of beneficiary/modification of limit of beneficiary etc. performed by the users.

<u>Please note</u>: All the users would get access to all the accounts covered under IBS by default. However, Account Administrator may allow/restrict access to various accounts linked under IBS to different users, as per the requirement of the corporate.
